# LFA Privacy Notice - Students

#### 1. Introduction

This Privacy Notice explains the basis on which London Film Academy ("LFA", "we", "our", "us") will collect and process personal information from its current students ("you/your").

As stated in section 9 below, you have the right to object to the use of your data for direct marketing, and (in certain circumstances) to the processing of your data on the basis of LFA's legitimate interests.

## 2. Scope of Notice

This notice applies to students enrolled on all LFA courses who are over the age of 18. For students under 18, please consult the separate privacy notice, <u>LFA Privacy Notice - Students under 18</u>.

## 3. Data we hold about you

The only personal data that we hold about you is personal data that you have provided to us or that relates directly to your application to enrol as a student and to your time as an LFA student.

For detailed information about the types of personal data submitted pertaining to each course, please consult <u>LFA Policy 2 - Recruitment</u>, <u>selection and admissions</u>, and associated procedures, and/or programme specifications or course outlines. For our courses, we would look to request, and or hold, some or all of the following information:

- Your name, date of birth, contact information (including email address, mobile and phone number, Zoom or Teams user ID, home address, residence address, correspondence address, next of kin contact details and address, emergency contact details), student number, nationality, country of birth, country of permanent residence, UK immigration history and requirements, criminal convictions. We will also ask you to upload 2 x passport photos;
- Course applied for, start date and admission decisions as well as information on how you intend to pay your fees, including bursary, scholarship or (government) loan applications;
- Personal statement and examples of your previous work; details about proficiency in English, education history, including predicted and actual results and qualifications awarded.
- CV or resume;
- Information about two referees;
- Data about how you heard about LFA;
- Coursework, assessment forms, grades, module results and course outcomes;
- Other information related to your studies, including film credits;
- Information provided on equipment book-out sheets & risk assessments:
- Bank account, debit or credit card details;
- Details of medical conditions that may impact your ability to participate on the course;
- Personal data to enable equal opportunities monitoring. LFA is committed to creating and
  maintaining a diverse, positive and supportive environment for its students. In order to monitor
  this, we collect equal opportunities monitoring information at the point of application. This includes
  your gender, gender ID, sexual orientation, ethnicity, disability, religion, or similar beliefs. Any
  such information will stay confidential and is kept separate from the application. It is not taken into
  account when considering candidates for a place at LFA.

In order to assist you with your Student Visa status and to ensure you meet the requirements for a Student Visa, we may hold the following personal information from you:

- Evidence of your knowledge of English (typically in the form of evidence of an IELTS);
- Proof of funding to demonstrate that you have sufficient funds to meet the Home Office's minimum requirement;
- Record of attendance.

Please note: we reserve the right to not issue a CAS to applicants who refuse to share this information with us.

## 4. Why we process your data

# **4.1.** What do we use your personal data for?

We will process the personal data that we hold about you for the following purposes:

- If applicable, to ensure you meet the ongoing requirements for a Student Visa;
- To administer bursary, and scholarship applications;
- To administer your record from recruitment, to application, enrolment, assessment and graduation;
- To support the provision of teaching and learning, assessment, monitoring and managing academic progress and academic misconduct, recording and monitoring attendance, recording and confirming of grades and awards;
- To assure, maintain and enhance academic standards;
- To provide optimum IT resources, including student logins to our Virtual Learning Environment; and access to other systems required or appropriate to complete your studies;
- To manage queries, complaints, appeals, allegations of misconduct, grievances and disciplinary actions;
- To ensure safety and wellbeing of all students;
- To engage with partner universities or other stakeholders;
- To report to regulatory bodies;
- To promote information on LFA courses or events, or other marketing activities.

## 4.2. Legal basis of processing

The legal grounds on which we process your personal data are as follows:

- Where the processing is necessary for us to perform a contract that you are party to, or to take steps at your request prior to entering a contract, that is the ground on which we are processing that data;
- Where the processing is necessary for compliance with a legal obligation to which we are subject, that is the ground on which we are processing that data;
- Where processing is necessary for the purposes of our legitimate interests, that is the ground on which we are processing that data, provided that your fundamental rights and freedoms which require protection of your data don't override those legitimate interests (our legitimate interests comprise furthering the aims and objectives of LFA);
- If you have given your consent to our processing the data, that is the basis on which we are processing that data.
- If more than one of the above grounds apply to the processing of data in question, the applicable ground will be the one that is set out first above.
- Where the basis on which we process data is that you have consented to the processing, you are entitled to withdraw that consent at any time.

#### 5. People with whom we share your information

## 5.1. Who has access to your data?

Access to your data is generally limited to LFA employees and only for the purposes outlined in section 4.

#### 5.2. How is it shared?

LFA does not sell your data to third parties. LFA will only share your personal data with third parties if this is necessary for the provision of our services and to comply with any legal obligation.

LFA may share your contact details with other students and tutors while you are a student on a course. We may also share some of your personal data with our validating university partner and the Office for Students for reporting purposes. Personal data held by LFA concerning Student Visa students will be shared with the Home Office (UK Visas and Immigration) if required to process a Confirmation of Acceptance for Studies (CAS). The UK Home Office reserves the right to request information on Student Visa students and LFA will typically comply with these requests. LFA retains the copyright to work (films or scripts) produced while on the course. As such LFA may share your details through entries to film festivals or competitions.



## 6. Means of storing data

Personal data about students is stored within our internal LFA database provided and hosted by a third-party provider. Access to this platform is secure and restricted to LFA staff. LFA enter into a data processing agreement with the provider that process your data on our behalf in order to ensure the same level of security and confidentiality of your data. LFA is committed to reviewing privacy and data protection policies of providers of third-party systems on a regular basis. Students', data may also be recorded in student and production files which are administered by LFA staff. These files are archived and subject to LFA's data retention policies.

#### 7. How long we will keep your data

While you are on the course, we will retain and continue to process any of the data you provide. After graduating from your course, your details are retained in accordance with our legal obligations and legitimate interests. LFA will take all reasonable steps to destroy, or erase from our systems, all personal data which are no longer required.

#### 8. Methods of communication

#### 8.1 How we will contact you?

Our communications are normally by email and most communications are only sent out via email. If, however, you have provided your phone number (mobile or landline), we may also contact you by phone. If you have provided an address, we may also contact you by post. If you use public social media profiles and have provided the details, we may also contact you via social media.

It is important to us that we always hold the most up-to-date information about you. To update your data that we hold, email <a href="mailto:privacypolicy@londonfilmacademy.com">privacypolicy@londonfilmacademy.com</a>.

## 8.2 Marketing communication

We will only send marketing communications to you where you have consented to receive them, or we are otherwise permitted by law to do so.

You can opt out of all marketing communications by emailing marketing@londonfilmacademy.com.

#### 9. Your rights

You have various rights under Data Protection legislation. These include:

- The right to ask us not to process your personal data for direct marketing purposes, even if you have given consent;
- If our processing is based on your consent, the right to withdraw any consent you may have given for our processing of your data if you exercise this right, we will be required to stop such processing if consent is the sole lawful ground on which we are processing that data;
- The right to ask us for access to the data we hold about you;
- The right to ask us to rectify any data that we hold about you that is inaccurate or incomplete;
- The right to ask us to delete your data in certain circumstances;
- The right to ask us to restrict our processing of your data in certain circumstances;
- The right to object to our processing of your data in certain circumstances;
- In certain circumstances, the right to require us to give you the data we hold about you in a structured, commonly used and machine-readable format so that you can provide the data to another data controller.

You can exercise any of the rights set out above, free of charge, by using any applicable methods set out in our communications with you, or by contacting us by emailing <a href="mailto:privacypolicy@londonfilmacademy.com">privacypolicy@londonfilmacademy.com</a>. In respect of most of the rights referred to above, your right may be qualified by Data Protection legislation, for example where our processing of data is for the purposes of the establishment, exercise or defence of legal claims. We may therefore not be able or required to fulfil your request, but we will discuss this with you following your request if necessary. Also, we may need more information from you, which we will ask You for following your request. We may ask you to provide further information in order to confirm your identity. Please also note that if you submit unfounded or excessive (for example repetitive) requests to exercise any of these rights, we reserve the right to make a reasonable charge for providing the requested information or taking the requested action, or to decline your request.





## 10. Complaints

You also have the right to lodge a complaint with the Information Commissioner's Office if you are concerned that we are not respecting your rights under Data Protection legislation. The Information Commissioner's Office is the authority in the UK, which is responsible for overseeing the application of, and enforcing, Data Protection legislation. We would prefer that you contact us first with any concerns, so that we have the opportunity to address your concern directly.
